CONTRACTOR hereby certifies and warrants that it has fully paid to date all laborers, subcontractors and suppliers retained by CONTRACTOR to supply materials or equipment, or perform work, labor or services at the Premises and that it has not and will not retain any subcontractors or suppliers for future work at the Premises.

Upon receipt of the Final Payment as set forth above, CONTRACTOR does hereby agree to defend, indemnify and hold harmless the Releasees and Releasees' respective agents, members, shareholders, partners, officers, directors, subsidiaries, affiliates, heirs, executors, administrators, successors and assigns from any and all claims, demands, suits, actions, liability, loss, damages, interest, expenses, judgments and liens (including but not limited to legal fees), of whatever kind or nature, directly or indirectly relating to the furnishing of work, labor, services, materials and/or equipment furnished

by CONTRACTOR and/or its agents, laborers, subcontractors or suppliers in connection with its work at the Premises.

Upon receipt of the Final Payment as set forth above, CONTRACTOR does hereby release and discharge the Releasees, Releasees' respective agents, members, shareholders, partners, officers, directors, subsidiaries, affiliates, heirs, executors, administrators, successors and assigns from all actions, causes of action, suits, debts, dues, sums of money, accounts, reckonings, bonds, bills, specialties, covenants, contracts, controversies, agreements, promises, variances, trespasses, damages, judgments, extents, executions, claims, and demands whatsoever, in law, admiralty or equity, which against the Releasees, CONTRACTOR, it's successors and assigns ever had, now have or hereafter can, shall or may have, for or upon, or by reason of any matter, claims or causes of action whatsoever from the beginning of the world to the day of the date of this Release.
